On what was then a ranch and is now

Boulevards, John W. Baumgartner was born
May 17, 1890. He was reared and educated
in Los Angeles, finishing at old St. Vincent's
College, now Loyola University.

After fifteen years in the practice of civil engineering he retired from the profession to engage in special assessments activities.

uncompromising foe of tax assessments. He served as chairman of various organizations opposing the levying of assessments against property in connection with the opening and widening of city streets, and materially aided the state legislation to amend the existing Public Improvement Procedure laws to prevent the confiscation of property through levying of special assessments.

Mayor Porter appointed Mr. Baumgartner to the Water and Power Commission March 14, 1932; the commission elected him president of the body March 30. During his incumbency the purchase of the Eaton Ranch and other large properties was accomplished by the city.

Then as now, Mr. Baumgartner championed

municipal ownership of essential public utilities, and has been in sympathy with the New Deal administration of President Roosevelt and his program of public ownership.

Elected to the City Council from the 12th district the first time in 1933 he has been returned to office every two years since then by the twelfth electorate.

In the council he enjoys the reputation of being a hard worker, thoroughly versed in municipal government, a level headed, even minded official who wastes no time on crack-pot schemes.

Throughout his incumbency he has served as chairman of the council's Water and Power Committee.

Mr. Baumgartner's residence in the city is in the general neighborhood of the site of his birthplace.

JOHN W. BAUMGARTNER

Mr. Baumgartner was born in the City of Los Angeles 47 years ago. He is by trade a Civil Engineer and received his education in local schools. Upon retiring from the Engineering profession in 1923 he devoted several years as Chairman of various organizations opposing the practice of levying confiscatory assessments against property in connection with the opening and widening of major arteries. He also took an active interest in the passage of State Legislation which served to amend the existing Public Improvement Proceedure Laws to prevent the confiscation of property through the levying of special assessments.

On March 14, 1932, Mr. Baumgartner accepted the appointment as a Member of the Board of Water and Power Commissioners and was elected President of the Board on March 30 of the same year. He filled this position for a period of fifteen months, resigning as President and Member of the Board on June 29, 1933.

Mr. Baumgartner is now serving his second term as a Member of the City Council and was recently reelected for a third term without opposition. During his entire incumbency he has acted as Chairman of the Council's Water and Power Committee. He is recognized as one of the most ardent supporters of our municipally owned Water and Power system. He is a life long Democrat and is acknowledged as a Progressive because of his political views and inclinations. Mr. Baumgartner had the honor to serve as an Elector on the Roosevelt-Garner ticket at the last Presidential Election.
