city employees themselves."

ACEA has been sponsoring a monthly "City Employee of the Month" award to honor outstanding employees nominated by department and bureau heads for extraordinary and exceptional work

ACEA President Whaley explained that officers and directors of his organization have decided to skip this month's selection in order to honor President Gibson in recognition of his long and distinguished service to the City of Los Angeles.

Of his 25 years on the City Council, Gibson has served as its president for 15 years.

In addition to his duties as Council President, Gibson often serves as Acting Mayor during the absence of Mayor Tom Bradley.

Gibson, who will be 74 years old on August 11, was once the youngest mayor in the United States. At the age of 23, he was City Chief in Genesco in his native Kansas.

A resident of San Pedro and Councilman of the 15th District, Gibson was a general contractor in the Harbor area for 10 years before he first was elected to the Council in 1951.

Gibson guest speaker at Bicentennial service

John S. Gibson Jr., president of the Los Angeles City Council, has been designated chief speaker at a Bicentennial worship service of Temple Baptist Church on Sunday, July 4, 3 to 6 p.m. at Old North

Church, Forest Lawn Memorial-Park, Hollywood Hills.

During the service, which is open to the public, the multiethnic diversity of the congregation will be stressed, with tributes in the spirit of the Bicentennial to members of Chinese, Korean, Latin, and European descent.

Following the service, members, many of whom will be

in either native or early American costume, will participate in folk dancing, musical presentations and games in the forecourt and greensward of Old North Church. Participating pastors from Temple Baptist will include Rev. James E. Conklin, Rev. Lionel Robaina, and Rev. Joseph Pang.

Old North Church within Forest Lawn-Hollywood Hills is a precise reproduction of the original in Boston Commons where the lighting of twin lanterns in the spire signaled the start of the midnight ride of Paul Revere and others to alert Minutemen in Lexington and Concord of the approach of a British expeditionary force.

Gibson, was born in Geneseo, Kan., and became the United States' youngest elected mayor when he assumed that office in his home town at the age of 21. He moved to Los Angeles in 1927, and was first elected to City Council in 1951.

He was elected City Council President in 1953, and has held that office since for a total of 16 years for the past nine years running.

Councilman John S. Gibson, Jr., is the new representative from the Fifteenth District, which covers the Harbor Area. He unseated George H. Moore, who had been in the Council since 1943. Mr. Gibson, who is married and the father of two children, was born in Geneseo, Kans., 49 years ago, but has made his home in the Southland for 23 years. He studied at the University of Kansas, and earned a certificate from the American Institute of Banking in Los Angeles. He became interested in politics in his home town, serving as Mayor of Geneseo from 1923 to 1925. For ten years before his election to the City Council, Mr. Gibson was engaged in the building contracting business. After his election, he sold his interest in the firm to his former associates. Mr. Gibson's civic activities included, among other things, member-

City Council 1951-1981 City Council President 1953-61, 1969-77

> Born: Geneseo, Kansas August 11, 1902 Attended University of Kansas Elected Mayor of Geneseo at the age of 21 in 1923, making him youngest such public official in the country.

In 1927 he and his Long Beach native wife Mina moved to California and he worked at his father-in-laws Dairy for a year before relocating to San Pedro in 1928. During these years he also graduated from the American Institute of Banking in Los Angeles and was president of the Citizens Bank of San Pedro. He was also the secretary of the San Pedro Junior Chamber of Commerce and founded the first Boys Club in California in 1938 in his hometown.

In 1941 John S. Gibson Jr. began a successful career as a General Contractor and for ten years was involved in that industry, remaining active in the business affairs of San Pedro. In 1951 he was elected to the Los Angeles City Council and by 1953 had gained enough stature to be named president of that body. For three decades he served as a folksy, popular but firm-handed councilman. Although a Democrat, Gibson was conservative, pro-business and a committed and devout Baptist who showed it in his decision-making.

By coincidence and Mayor Yorty's frequent travels, the burden of dealing with the Watts Riots fell on Gibson's shoulders where he gained respect for his calm and reasoned approach to handling the crisis.

Gibson had several unsuccessful bids for mayor, congressman, and county tax assessor but maintained a stellar career on the council setting standards for length of service (29 years) and as president for sixteen years. John S. Gibson Jr. is the only council member to be named President Emeritus upon his retirement in 1981. He died at his home in San Pedro on April 22, 1987.
