Born December 28, 1859, in Delaware County, New York, William Henry Pierce received his early education in the public schools of the county, later graduating from Walton Academy, Walton, New York.

At nineteen years of age he taught district school for one year before coming to Sacramento, California, in 1880, where he joined his brother in the grocery business. The following year he spent with another brother in Sierra Madre and then moved to the Mother Lode gold country and operated a general store for a year at Mokolume Hill, Calaveras county.

Removing to Los Angeles in 1885 Mr. Pierce engaged in the livery stable business with his two brothers, and later engaged in raising grain and hay out on the Mission Road near the city limits.

In 1898 Mr. Pierce was elected to the City

Council from the 1st ward, which is now the Lincoln Heights district. Reelected to a second
term he served until 1903. During his two terms
the Council, while working on problems of the
city's water supply, took over the water rights
from private control and interests.

In 1902 Mr. Pierce and his brothers entered the mortuary business under the corporate firm name of Pierce Brothers & Company.

Planning Commission from 1920-1922. This Commission was composed of fifty-one members and was an outgrowth of the City Planning Association formed primarily to prepare a program of civic improvements to create employment for returned soldiers of the World War. Mr. Pierce continued to serve on the regular City Planning Commission, as a Commissioner, until 1925.

After resigning from public office he retired, also from political life to devote his energies to his undertaking establishments.

At present Mr. Pierce is president of Pierce Brothers Mortuary, and makes his home in Los Angeles.





# DEATH TAKES W. H. PIERCE, CIVIC LEADER

President of Nation's Second Largest Funeral Firm Dies Unexpectedly at Sanitarium

Death yesterday summoned William H. Pierce, 79, Los Angeles pioneer, civic leader and president of Pierce Brothers, the nation's second largest funeral direction firm.

Mr. Pierce died unexpectedly at the Chase Sanitarium of a heart ailment. Close friends attributed his ailment to grief over the death of his son, Dr. Sterling Pierce, noted obstetri-

cian, who was killed in an automobile accident three months ago.

#### FUNERAL MONDAY

Funeral services will be held Monday at 10 a. m. at the First Unitarian Church, and interment will be made on Mr.

Pierce's Hemet ranch.

Mr. Pierce was president of Pierce Brothers Mortuary, and for many years was a civic leader in Los Angeles. He was born in Delaware County, New York, Dec. 28, 1859. He was graduated from Walton Academy of Walton, N.Y., and came to California in 1880.

In 1884 he organized a furniture company operating in the old Plaza district. In 1902 he formed the Pierce Brothers Mortuary Co.

#### SERVED IN COUNCIL

From 1898 until 1902 Mr. Pierce served two terms on the Los Angeles City Council.

During his 55 years of civic service in Los Angeles, Mr. Pierce played a leading part in the reform of city, county and State government. He helped to organize the first City Planning Commission and served two terms as its president.

Mr. Pierce also organized the first City Traffic Commission and served one term as its presi-Before the Chamber of dent. Commerce was ever known he organized the Business Men's Association, which later became the Chamber of Commerce.

### BELONGED TO LODGES

Mr. Pierce was a member of the Masonic, Elks, Odd Fellows and Woodmen of the World lodges. For many years he was a director of the old Commercial and Union League clubs.

Up until the time of his death Mr. Pierce made his home at 2118 S. Hobart Blvd. He leaves his widow, Mrs. Mary Newton Pierce; two daughters, Mrs. Helen Hum and Mrs. Gertrude Johnson; two brothers, Dr. C. W. Pierce, member of the Board of Education, and Herbert Pierce, and a sister, Mrs. Catherine Wheat, all of Los Angeles.
