#### **ANECDOTES AND PERSONAL IMPRESSIONS:**

In 1874 when Samuel Rees arrived in Los Angeles the city's population was 6500 persons. From that day to the time of his death forty years later Mr. Rees was an enthusiastic believer in the future of Los Angeles as a great metropolis.

He pioneered in business, real estate, and civic development, all toward this end, and remained progressive minded throughout his career.

When he built his home on his unimproved land in Brooklyn Heights there were no roads, streets, sewers, or improvements of any sort; water for domestic purposes had to be carted to the premises in barrels.

A clever and facile rhymster, with a flair for the caustic, Mr. Rees is said to have enlivened numerous council and business meetings with verse about his associates and subjects before the board.

Samuel Rees was born October 3, 1846, in Staffordshire, England. He received very little formal education as the necessity of earning a livlihood obliged him to leave school at an early age. At twenty-one years of age he left the shires and emigrated to America to seek his fortune.

Before pioneering to Los Angeles in 1874 he clerked for the Pennsylvania railroad in Panhandle division 4, in Pittsburg about seven years.

In Los Angeles Mr. Rees served as bookkeeper for a firm of blacksmiths and wheelwrights until he had sufficient money saved to enter business for himself, which he later did with Robert E. Wirshing as partner. This pioneer firm, which was one of the first business houses in Southern California to order goods directly from the east, engaged in general blacksmithing and manufacture of wagons in a large shop on Aliso street.

The firm, though sustaining losses of \$15,000 in the great floods of 1884, prospered, and later purchased the business of another large firm and after adding a stock of modern agricultural implements established headquarters on Los Angeles street.

During these years, while engaging in business. Mr. Rees backed up his faith in the future of Los Angeles by purchasing unimproved land remote from the business and residential centers of the city. He bought seventeen acres, at \$20 per acre, on the east side in what later became Brooklyn Heights, which he improved and developed, and upon which he built his home. He also pioneered in real estate ventures in other unpopulated sections of Los Angeles.

In 1891 Mr. Rees was elected to the City Council from the 9th ward, serving two years. While a member of the Council he served as chairman of the Finance Committee, and on the Zanja, and Gas and Light committees. At the same time he served on

the Board of Public Works, which at that period was composed of five members from the City Council.

Mr. Rees was largely responsible for the establishment of Hollenbeck Park as it is today. Through his efforts he increased the original gift of three and one-half acres of land from Mrs. Hollenbeck and ex-Mayor Workman to about thirty acres, and succeeded in having the gift accepted and sufficient amount appropriated for its development and maintenance during his councilmanic days.

Mr. Rees died October 24, 1914, at his home in Los Angeles.
