Lloyd G. Davies, Councilman, 2nd District

Since 1943, Lloyd G. Davies has been the Hollywood representative in the City Council.

Born in Los Angeles, the 34 year old legislator attended Los Angeles public schools and later took two and a half years extension work in law and civil engineering.

Davies first went to work for the City of Los Angeles in 1935 when he was employed by the Department of Water and Power. He left the department in 1940 to enter business for himself. Subsequently he was associated with the Merchants and Manufacturers association as a public relations representative, during which time he also held a partnership in an advertising agency. In addition to his other activities, Davies has retained an interest in his father's cattle business since 1930.

He second district councilman is a member of the Hollywood Lions club, Hollywood Chamber of Commerce, Hollywood Junior Chamber of Commerce, United Commercial Travelers, Native Sons of the Golden West, Los Angeles County Mounted Sheriff's Posse, Hollywood YMCA, and the Hollywood Taxpayer's association.

One of the youngest members of the Council, Davies relaxes from his official duties by hunting, fishing and horseback riding. He also has an active interest in agriculture.

Councilman and Mrs. Davies live at 1718 North Sierra Bonita avenue, Hollywood. They have three children, Patricia Mary, 8, Joanne Bronwyn, 5, and Lloyd, Jr., 1.
